Tuition Agreement for Dance Season

All accounts must have a valid Visa, MasterCard, or American Express Card on file and a valid email address that is checked weekly. I understand that Arizona Dance Artistry will update me about billing, performances, class changes, studio events, etc. through email. It is my responsibility to check this regularly to stay informed about studio information.

All tuition is **automatically billed 5-10 days prior to session start date**. Tuition reminders will be sent out 7-10 days prior to billing date and are posted in the studio. If you wish to make any changes to your enrollment or payment method, this alternate way of payment must be made 5 days before the auto bill date. Please see auto bill schedule below.

I understand that if I do NOT notify the studio in writing of my dancer discontinuing classes PRIOR to bill date, I will be charged full tuition for that upcoming session. Confirmation of class drop required from both Arizona Dance Artistry and Enrolled Family. I understand that if my dancer discontinues classes after tuition has been paid, partial or full credit or refunds are NOT GIVEN. I understand that my dancer may continue the remaining portion of the session that has been paid for and the drop from the program with written notice. Family must notify AZDA Office Staff of discontinuation of enrollment 10 days prior to session start date to withdraw from auto billing.

I understand that when I enroll my dancer, they will remain enrolled in all classes until I notify Arizona Dance Artistry in writing, or the 2016-2017 dance season has come to an end.

I understand that tuition is non-refundable and non-transferable to any other student or session.

I understand that a weekly, **recurring \$15 late fee** will be applied to my account so long as tuition is past due. I understand that **after 3 weeks of late tuition, my dancer will not be permitted to return to class** until tuition is cleared.

I understand that all costumes and merchandise are non-refundable.

Tuition Information

- Tuition is charged per hour, not per class. Rates are based on 11-week sessions. Each additional hour is offered at a discounted rate. The most savings is in our Unlimited Class Plan, which offers dancers to enroll in 6 hours or more a week for a flat rate.
- Payment plan options are available; please contact Office Manager, Mikayla Hudson for more details at mikayla.azda@gmail.com. If family has opted for participation in the Optional Payment Plan, family must fill out and sign contract, and use automatic payment on scheduled days. Same late fee and class policies apply.
- In the event of low enrollment in a particular class, the schedule may be adjusted. Classes may be canceled or combined if less than 7 students are enrolled. There is no fee for a dancer to change classes for this reason. If a class is cancelled and you cannot attend the adjusted class schedule, a full refund will be given.

Automatic Billing

I understand that my card on file will automatically be charged on the following dates unless:

1. I have notified the office in writing 5-10 days prior of the elected billing date
2. I have been approved for and signed an optional payment plan agreement

I understand that Arizona Dance Artistry has the right to withhold any costumes, ticketing privileges, or merchandise until my account is in good-standing.

I understand that my dancer's tuition will be reflected based off of how many hours per week I enroll my child in. If I add any classes, the adjusted tuition will be charged right away.

Scholarships and Discounts

Boys Scholarship Information

Boys who enroll in coed classes receive unlimited scheduling for a seasonal participation fee of only \$200 (must be 5yrs old by start of season). Unlimited level/age appropriate classes may be scheduled at the front desk. Scholarship had been updated this season, boys must be enrolled in Jazz or Ballet for scholarship to go into affect. Boys enrolled in only Hip Hop and/or Acro will pay regular tuition. This offer may not be combined with any other specials or sibling discounts.

Tuition Discounts

- We offer a 15% sibling discount
- 3% discount for paying an entire semester (2 sessions) in advance
- 6% discount for paying full year in advance (4 sessions)
- \$50 referral coupon applied when any friend NEW to AZDA enrolls in class *Applied in 2 \$25 coupons split over 2 billing sessions to ensure family stays enrolled in classes.

Missed Class Policies

I understand that I have 2 weeks (before or after) any missed classes to schedule a make-up class for my dancer. I understand that Arizona Dance Artistry does not give credit and/or refunds for any class(es) missed due to holiday, vacation, illness, weather, emergency, etc. I understand I can schedule a make-up class online or through the office.

I understand that excessive absences can result in my child missing out on choreography, performances, and potentially dropped from classes. Instructors are not responsible for making up any curriculum or choreography a student may have missed.

Studio Conduct Policies

As a member of the Arizona Dance Artistry community, I understand that myself and my dancer must treat this dance community with respect. I understand that it is never appropriate to talk negatively about other dancers and/or families. I understand that I should encourage a positive learning environment for my dancer. I understand that I should treat the dance studio with respect and play my part in maintaining a clean, warm, welcoming environment.

I understand that Arizona Dance Artistry reserves the right to discontinue services to dancers/families that do not oblige to our Studio Conduct Policies.

Photos and Social Media

I understand my dancer may be photographed or filmed in classes or studio events, and I release the right for the studio to use my child in marketing or promotion material.

I have received or will obtain a copy of Arizona Dance Artistry policies and will take the responsibility to carefully read and follow the rules and policies therein. I further understand that there are specific risks of physical or property damages, losses, or injury that may result from my or my child's participation with Arizona Dance Artistry, and I voluntarily assume the risks associated with such participation.

Electronic Signature Agreement. By selecting the "I Accept" checkbox, I am signing this agreement electronically. I agree this electronic signature is the legal equivalent of my manual signature on this agreement.
